TRAINING OBJECTIVES

1. History: learn why aging occurs, where injectables come in, as well as the mechanism of action of injectables.
2. Neurotoxin and Dermal Fillers: Learn indications, contraindications, pharmacology, intro rheology, pathophysiology, and more
3. Safety: review guidelines, side effects, adverse reactions, risk, choosing the right client, and the management thereof
4. Medication Administration: determine accurate and appropriate dosing, preparation, and administration of client specific medications
5. Business Model: Receive step by step instruction on what you need to start your own practice, or to set yourself up for success to join a successful aesthetic practice
6. Anatomy: Review of muscular, vascular, as well as global anatomy.
7. Patient evaluation: Medical aesthetic specific assessment pre, intra, + post procedure
8. Procedure: Instruction on how to perform basic procedures including neurotoxin for forehead lines, frown lines, crow's feet, lip flip, and dermal filler for lip augmentation and perioral lines as well as aseptic technique procedures
9. Professionalism: Learn aesthetic bedside manner, client comfort, verbiage, client-injector relationships, dealing with the difficult client, when to say no, setting clear expectations, boundaries, and more
10. Complications: Learn best practices to avoid complications and how to manage in the event they occur

3. Once these two steps are complete, please email us stating which training date you would like to attend. We will then send you an invoice via email to complete payment. Please be advised, that your seat is not held until payment is received in full. Payments via invoice may be in the form of credit card (3.3% + .30 fee) or bank transfer (1%) fee. We also accept Zelle or check.

4. You will receive further instructions via email after steps 1-3 are completed including confirmation of registration and payment, tentative training schedule, information for models, and address of lecture training day will be held at 417 Refine in Springfield, MO: *2918 E Battlefield Rd*, or in Joplin, MO: *516 S Virginia Ave*. Please be prepared to stay for the entirety of your training or certification may be withheld.

5. It is ideal that your model be prepared to receive both neurotoxin and dermal filler injections; however, if this is challenging, you may source two models, one for each service. More information will be provided once registration is confirmed.

Registration fee is non-refundable, non-transferable, and required in full at time of registration.

IN PREPARATION FOR CLINICAL

Training Models:

- We ask that you have a model who is eager and willing to be your model during the hands-on clinical day. It is ideal that one model will receive neurotoxin injections *to the forehead, frown lines, and crows feet*, as well as receiving dermal filler *to the lips and/or lines around the mouth*. If this is challenging, you may source two models, one for each service. These models will be only for your training, not shared. They must be willing to sign a photo release + waiver, and be flexible on their appt time between 2-5:00pm. Once you have your models, please email their full name, DOB, email, phone number, address, and any allergies to medication to cassi@417refine.com no later than two weeks prior to training.
- Your model should not have had any neurotoxin treatments within the past three months, has never had lip filler ideally, and is ready to receive both at the training by you. This will benefit your learning experience.
- If you have trouble finding models, please let us know as soon as possible so that we may start assisting in recruiting for you, although we can not guarantee this. Providing models for your training is ultimately the student's responsibility.
- Your models will be contacted with an appointment time once the clinical day schedule is confirmed. This will be done closer to training. We ask again that your models be flexible on the day of training regarding their appointment time. For models, neurotoxin will be \$8/unit and dermal filler will be \$299 for half of a syringe. We will only use 1/2 syringes for training.
- If your models ask, we carry and use all brands of tox and filler. For training purposes, we mostly use Jeuveau for neurotoxin and RHA or Versa for dermal filler.
- Please instruct your models to look for an email from us with their appointment time and direction to complete our forms and waivers. They will also have access to review our pre and post procedure instructions which they should fully review.
- They should be prepared for expected potential side effects of injections including but not limited to minor swelling and bruising. If they have any important events coming up in the two weeks following, they are not a good candidate to be a model for training. These side effects should resolve within two weeks for most.
- Development of a cold sore is possible after receiving lip injections. If your model has a history of cold sores and would like to start a prophylactic antiviral, please let us know via email so this prescription can be sent in prior to the training weekend. This may help prevent a cold sore from developing and needs to be started 72 hrs prior.

You will be expected to stay for the entirety of the training on both days.
Failing to do so may prevent you from obtaining your proof of training certificate.

You will receive a certificate of completion at the conclusion of the training.
